- * **Delta Drive**, Kentucky DOF. Six miles east of Cumberland, KY. Timber and medium slash. Moderate fire behavior with creeping and smoldering. Residences threatened.
- * **Rocklick**, Virginia DOF. Nine miles northwest of Grundy, VA. Timber and brush. Moderate fire behavior with backing. Structures threatened.
- * **Tennessee 68**, Tennessee DOF. Started on private land two miles northeast of Turtletown, TN. Timber, dormant brush and hardwood slash. Moderate fire behavior with uphill runs, backing and wind-driven runs.
- * **Sidney**, Kentucky DOF. Thirteen miles northeast of Pikeville, KY. Closed timber litter and grass. Active fire behavior with running, flanking and creeping. Numerous structures threatened.
- * **Hicks Branch**, Kentucky DOF. Started on private land four miles northeast of Pikeville, KY. Hardwood litter and medium slash. Minimal fire behavior with creeping and smoldering.

Predictive Services Discussion:

A cold front will move off the Gulf and Southeast Coasts and stall just offshore while extending through the Florida Peninsula during the weekend. Showers and thunderstorms will extend from south Texas into portions of the Southeast today and tomorrow. A weak upper low will track across northern Mexico and Texas this weekend into early next week bringing showers and thunderstorms to the southern half of Texas and much of the Lower Mississippi Valley, Deep South, and Gulf Coast early to mid-next week. To the north of the rainfall, dry and breezy conditions are likely early to mid-next week across portions of the southern and central Appalachians, Mid-Atlantic, and Carolinas into the Ohio and Tennessee Valleys. Dry and breezy conditions are also likely on portions of the southern and central High Plains today and continuing on portions of the central High Plains extending into the northern Plains through the weekend. Above normal temperatures will develop across much of the Plains, Great Lakes, and Intermountain West this weekend into mid-next week. Low relative humidity will also continue in the Desert Southwest through the weekend, with offshore flow in southern California. Precipitation will move into the Pacific Northwest, mostly along and west of the Cascades into the weekend, with some precipitation making it to the northern Rockies. Another wave of precipitation will likely spread down the West Coast early to mid-next week.
