Pioneer, Southeast Region, Washington DNR. CIMT (CA Team 15). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with uphill runs, flanking and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with uphill runs, backing and single-tree torching. Structures threatened. Area, road and trail closures in effect.

Diamond Complex (8 fires), Umpqua NF, USFS. CIMT (NR Team 3). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, backing and torching. Structures and energy infrastructure threatened. Area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Active fire behavior with flanking, group torching and short-range spotting. Structures threatened. Trail closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (SW Team 5) and CIMT (CA Team 1). Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Active fire behavior with uphill runs, group torching and spotting. Numerous residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Falls, Malheur NF, USFS. CIMT (AK Team 1) and CIMT (NW Team 2). IMT is also managing the Telephone and Sand fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Sand, Malheur NF, USFS. Five miles southeast of Izee, OR. Timber and grass. Active fire behavior with short crown runs, running and spotting. Area, road and trail closures in effect.

Lane 1, East Lane Unit, ODF. CIMT (NC State Team 1). Fifteen miles southeast of Springfield, OR. Timber and light slash. Active fire behavior with group torching, uphill runs and backing. Structures threatened. Area and road closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (AK Team 3). Transfer of command from CIMT (RM Team 1) to CIMT (CA Team 13) will occur today. IMT is also managing the Ore fire. Eight miles southeast of Oakridge, OR. Brush and timber. Minimal fire behavior with backing, creeping and smoldering. Infrastructure threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with backing, torching and spotting. Structures threatened. Area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. Transfer of command from CIMT (NR Team 1) to CIMT (CA Team 14) will occur today. Started on private land 14 miles southeast of Naches, WA. Grass and timber. Active

fire behavior with flanking, torching and short-range spotting. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Homestead Complex (6 Fires), Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber and brush. Active fire behavior with flanking, backing and short-range spotting. Area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. CIMT (NR Team 2). IMT is also managing the Sandstone and Microwave fires. Six miles southeast of Cascade Locks, OR. Timber. Moderate fire behavior with single tree torching, spotting and backing. Area, road and trail closures in effect.

* **Sandstone**, Mt. Hood NF, USFS. Nine miles southwest of Ripplebrook, OR. Timber, medium slash and chaparral. Extreme fire behavior with wind-driven runs, group torching and short-range spotting. Area, road and trail closures in effect.

Microwave Tower, The Dalles Unit, Oregon DOF. Five miles southwest of Mosier, OR. Grass and timber. Minimal fire behavior with smoldering and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. Transfer of command from IMT 1 (ODF Team 1) to CIMT (SW Team 3) will occur today. Eight miles north of Ukiah, OR. Grass, brush and timber. Active fire behavior with uphill runs, single tree torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 12). Twenty-three miles southwest of Asotin, WA. Timber and brush. Minimal fire behavior with smoldering, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Lone Rock, Prineville District, BLM. Transfer of command from CIMT (SW Team 2) back to the local unit will occur tomorrow. IMT is also managing the Courtrock fire. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with smoldering.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Moderate fire behavior with single tree torching and smoldering. Numerous structures threatened. Area and road closures in effect.

Red, Deschutes NF, USFS. Transfer of command from CIMT (EA Team 1) back to local unit will occur today. Eighteen miles west of Crescent, OR. Timber. Active fire behavior with creeping, backing and single tree torching. Numerous structures threatened. Area, road and trail closures in effect.

Swawilla I, Colville Agency, BIA. Transfer of command from CIMT (SA Team 2) back to local unit will occur today. Ten miles southwest of Keller, WA. Grass, brush and timber. Minimal fire behavior with flanking, backing and single tree torching. Numerous residences threatened. Area, road and trail closures in effect.

Durkee, Vale District, BLM. Started on private land one mile west of Durkee, OR. Grass and timber. Minimal fire behavior with flanking, backing and smoldering. Structures, infrastructure and sage-grouse habitat threatened.

Williams Mine, Gifford Pinchot NF, USFS. CIMT (NW Team 13 mobilizing). Four miles northwest of Trout Lake, WA. Timber, medium slash and chaparral. Extreme fire behavior with running, group torching and short-range spotting. Community of Trout Lake threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Town Gulch, Wallowa-Whitman NF, USFS. CIMT (SA Team 2) mobilizing. Eight miles north of Richland, OR. Timber and grass. Extreme fire behavior with uphill runs, flanking and backing. Communities of Halfway and New Bridge threatened. Evacuations, area and road closures in effect.

Elk Lane, Prineville District, BLM. Six miles west of Madras, OR. Brush, grass and timber. Moderate fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, area and road closures in effect.

Warner Peak, Sheldon-Hart Mountain NWR, FWS. Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with wind-driven runs, running and flanking. Structures threatened. Area and road closures in effect.

Soldier Creek, Vale District, BLM. Sixteen miles southwest of Jordan Valley, OR. Grass and brush. Moderate fire behavior with smoldering. Sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

Salmon Creek, Northeast Region, Washington DNR. Started on private land three miles southeast of Conconully, WA. Grass, brush and timber. Minimal fire behavior with torching and backing. Structures threatened.

Porcupine, Burns District, BLM. Thirty-five miles southeast of Burns, OR. Grass, brush and timber. Moderate fire behavior with flanking, creeping and smoldering. Sage-grouse habitat threatened.

Badland Complex, Vale District, BLM. Three miles northeast of Durkee, OR. Brush and timber. Minimal fire behavior with smoldering. Structures and sage-grouse habitat threatened. Last report unless significant activity occurs.

Winding Waters Complex, Wallowa Unit, ODF. Twenty-three miles east of Union, OR. Timber and brush. Minimal fire behavior with smoldering and creeping. Area, road and trail closures in effect. Last report unless significant activity occurs.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Energy infrastructure threatened. Area closure in effect.

Paddock, Boise District, BLM. Twenty-one miles northeast of Payette, ID. Grass and brush. Active fire behavior with uphill runs, wind-driven runs and flanking. Numerous structures and sage-grouse habitat threatened. Evacuations in effect.

* **Bulldog**, Boise NF, USFS. CIMT (NR Team 5) mobilizing. Started on BOR land eight miles north of Garden Valley, ID. Timber and grass. Active fire behavior with wind-driven runs, group torching and uphill runs. Numerous structures threatened.

Limepoint, Payette NF, USFS. CIMT (SA Team 1). IMT is also managing the Cliff Mountain fire in the Northwest Area. Three miles southwest of Cuprum, ID. Grass, brush and timber. Moderate fire behavior with creeping, isolated torching and smoldering. Structures, energy and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Wolf Creek, Payette NF, USFS. CIMT (GB Team 7). CMIT (GB Team 2) mobilizing. IMT is also managing the Boulder, Wapiti and Bulltrout fires. Eleven miles northwest of Cascade, ID. Timber and brush. Active fire

behavior with group torching, spotting and flanking. Structures threatened. Area, road and trail closures in effect.

Boulder, Boise NF, USFS. Nine miles southwest of Cascade, ID. Timber and brush. Active fire behavior with group torching, spotting and flanking. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Wapiti, Boise NF, USFS. Fourteen miles west of Stanley, ID. Timber. Active fire behavior with group torching, spotting and flanking. Structures threatened. Evacuations, area, road and trail closures in effect.

Bulltrout, Boise NF, USFS. Fifteen miles northwest of Stanley, ID. Timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Dry Fork, West Desert District, BLM. Ten miles southwest of Randolph, UT. Timber and Brush. Active fire behavior with running, isolated torching and short-range spotting. Residences threatened.

Leeds Creek, Bridger-Teton NF, USFS. Eighteen miles southwest of Dubois, WY. Heavy slash and timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closure in effect. Reduction in acreage due to more accurate mapping.

Above normal temperatures will continue along the West Coast into the Great Basin, with the greatest anomalies forecast west of the Cascades and Sierra. Dry conditions with humidity as low as 5-20% will continue across much of the West with poor overnight recovery. Northeasterly sustained winds of 12-22 mph with gusts up to 30 mph will develop in the Columbia Basin. Easterly winds of 8-20 mph with gusts up to 40 mph will develop in the central Cascades from Mt. Jefferson to Mt. Rainier, strongest in the Columbia Gorge and Cascade gaps. Thermal troughing will also develop near the Oregon/Washington Cascades enhancing low-level instability. Farther south, breezy afternoon southwesterly sustained winds of 12-20 mph with gusts to 30 mph will develop in northeast California and southeast Oregon into northern Nevada.

Scattered to widespread wet thunderstorms are likely in eastern Wyoming and east of the Divide in Colorado, with heavy rains possible on the recent burn scars on the Front Range where debris flows could occur. Scattered mainly wet thunderstorms are also likely in the Southwest, southern Great Basin, and southeast California. Hot and dry conditions will continue in much of Texas and Oklahoma. A cold front will move through the Texas Panhandle and Oklahoma in the afternoon and evening bringing north winds near 20 mph, although humidity will increase with cooling temperatures. Tropical Storm Debby will slowly move north bringing heavy rain in the eastern Carolinas into the Mid-Atlantic, with areas of flooding.
