Sixty-six fireline management personnel from Australia and New Zealand are assigned to support large fires in the Northwest Area.

Town Gulch, Wallowa-Whitman NF, USFS. CIMT (SA Team 2). Eight miles north of Richland, OR. Timber and grass. Active fire behavior with flanking, creeping and single tree torching. Several communities threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Williams Mine, Gifford Pinchot NF, USFS. CIMT (NW Team 13). Four miles northwest of Trout Lake, WA. Brush, timber and light slash. Active fire behavior with running, group torching and spotting. Community of Trout Lake threatened. Evacuations, area, road and trail closures in effect.

Pioneer, Southeast Region, Washington DNR. CIMT (CA Team 15). IMT is also managing the Easy fire. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Active fire behavior with uphill runs, flanking and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber and brush. Active fire behavior with uphill runs, backing and single tree torching. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Diamond Complex (8 fires), Umpqua NF, USFS. CIMT (NR Team 3). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Active fire behavior with flanking, backing and isolated torching. Structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber and brush. Active fire behavior with flanking, short-range spotting and backing. Structures threatened. Trail closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (AK Team 3) and CIMT (CA Team 13). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Brush and timber. Moderate fire behavior with uphill runs, backing and creeping. Infrastructure threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Brush and timber. Active fire behavior with uphill runs, torching and short-range spotting. Structures threatened. Area, road and trail closures in effect.

Lane 1, East Lane Unit, ODF. IMT (ODF Team 1). Fifteen miles southeast of Springfield, OR. Timber and light slash. Active fire behavior with uphill runs, torching and spotting. Structures threatened. Evacuations, area and road closures in effect.

Crazy Creek, Ochoco NF, USFS. CIMT (CA Team 1). Sixteen miles northeast of Paulina, OR. Grass, brush and timber. Active fire behavior with flanking, group torching and spotting. Numerous residences and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Cougar Creek, Southeast Region, Washington DNR. CIMT (NW Team 12). Twenty-three miles southwest of Asotin, WA. Timber and brush. Active fire behavior with smoldering, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Homestead Complex (6 Fires), Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber and brush. Active fire behavior with flanking, short-range spotting and backing. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Battle Mountain Complex (2 fires), Pendleton Unit, Oregon DOF. CIMT (SW Team 3). Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Moderate fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Retreat, Southeast Region, Washington DNR. CIMT (CA Team 14). Started on private land 14 miles southeast of Naches, WA. Grass, brush and timber. Active fire behavior with smoldering, creeping and backing. Numerous structures, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Falls, Malheur NF, USFS. CIMT (NW Team 2). IMT is also managing the Telephone and Sand fires. Twenty-six miles northwest of Burns, OR. Timber and grass. Active fire behavior with flanking, isolated torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Telephone, Malheur NF, USFS. Sixteen miles northeast of Burns, OR. Timber and grass. Moderate fire behavior with isolated torching, backing and creeping. Area, road and trail closures in effect.

Sand, Malheur NF, USFS. Five miles southeast of Izee, OR. Timber and grass. Active fire behavior with flanking, isolated torching and short-range spotting. Area, road and trail closures in effect.

Sandstone, Mt. Hood NF, USFS. CIMT (NR Team 2). IMT is also managing the Whisky Creek fire. Nine miles southwest of Ripplebrook, OR. Timber, medium slash and chaparral. Moderate fire behavior with single tree torching, backing and creeping. Area, road and trail closures in effect.

Whisky Creek, Mt. Hood NF, USFS. Six miles southeast of Cascade Locks, OR. Timber. Moderate fire behavior with isolated torching, backing and creeping. Area, road and trail closures in effect.

Lone Rock, Prineville District, BLM. CIMT (SW Team 2). IMT is also managing the Courtrock fire. Started on county land 10 miles southeast of Condon, OR. Timber and grass. Minimal fire behavior with smoldering.

Courtrock, Fossil Unit, ODF. Seven miles south of Monument, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Area and road closures in effect.

Warner Peak, Sheldon-Hart Mountain NWR, FWS. CIMT (SW Team 1). Thirty-two miles northeast of Lakeview, OR. Brush and grass. Active fire behavior with wind-driven runs, flanking and short-range spotting. Structures threatened. Area and road closures in effect.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber. Minimal fire behavior with creeping, single tree torching and smoldering. Numerous structures threatened. Area, road and trail closures in effect.

Elk Lane, Prineville District, BLM. Six miles west of Madras, OR. Brush, grass and timber. Minimal fire behavior with smoldering. Numerous structures threatened. Road closures in effect.

Porcupine, Burns District, BLM. Thirty-five miles southeast of Burns, OR. Grass, brush and timber. Minimal fire behavior with smoldering. Sage-grouse habitat threatened.

Cliff Mountain, Wallowa-Whitman NF, USFS. Twenty-five miles east of Joseph, OR. Grass, brush and timber. Minimal fire behavior with creeping and smoldering. Energy infrastructure threatened. Area closure in effect.

Durkee, Vale District, BLM. Started on private land one mile west of Durkee, OR. Grass and timber. No new information.

Swawilla I, Colville Agency, BIA. Ten miles southwest of Keller, WA. Grass, brush and timber. No new information. Last report unless new information is received.

Middle Fork Complex (3 fires), Boise NF, USFS. CIMT (NR Team 5). IMT is also managing Wapiti and Bulltrout fires. Nine miles east of Garden Valley, ID. Timber and grass. Active fire behavior with uphill runs, group torching and short-range spotting. Numerous structures threatened. Area, road and trail closures in effect.

Wapiti, Boise NF, USFS. Fourteen miles west of Stanley, ID. Timber. Active fire behavior with uphill runs, group torching and short-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Bulltrout, Boise NF, USFS. Fifteen miles northwest of Stanley, ID. Timber and brush. Minimal fire behavior with creeping, torching and smoldering. Structures threatened. Area, road and trail closures in effect.

Boulder, Boise NF, USFS. CIMT (GB Team 2). IMT is also managing the Wolf Creek, Snag and Dollar fires. Nine miles southwest of Cascade, ID. Timber and brush. Active fire behavior with isolated torching, spotting and flanking. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Wolf Creek, Payette NF, USFS. Eleven miles northwest of Cascade, ID. Timber and brush. Moderate fire behavior with torching, backing and flanking. Structures threatened. Road and trail closures in effect.

Snag, Boise NF, USFS. Ten miles east of Cascade, ID. Timber. Active fire behavior with crowning, running and spotting. Residences threatened. Area, road and trail closures in effect.

Dollar, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and grass. Active fire behavior with group torching, spotting and flanking. Residences threatened. Area, road and trail closures in effect.

Flat, Southwest Area, Idaho Department of Lands. Eleven miles north of Idaho City, ID. Timber. Active fire behavior with flanking, group torching and spotting. Structures threatened. Area, road and trail closures in effect.

Limepoint, Payette NF, USFS. Transfer of command from CIMT (SA Team 1) to CIMT (GB Team 4) will occur today. IMT is also managing the Cliff Mountain fire in the Northwest Area. Three miles southwest of Cuprum, ID. Grass, brush and timber. Active fire behavior with creeping and torching. Structures, energy and communication infrastructure threatened. Area, road and trail closures in effect.

Predictive Services Discussion:

The ridge of high pressure over the western US will continue to break down and a deeper troughing pattern will develop over the West Coast. Temperatures west of the Divide will cool a little more, averaging just a few degrees above normal. Humidity will increase modestly, especially west of the Sierra. RH will remain elevated in the Cascade gaps into portions of the Columbia Basin, generally above 25%. Significant fire potential will continue to be reduced over the Northwest thanks to the added moisture and cooler temperatures. However, dry conditions will continue across interior portions of the West, especially southeast Oregon and the northern/western Great Basin, with RH around 8-25% with poor overnight recoveries, especially California and Nevada. Breezy westerly flow of 15-25 mph with gusts to 35-40 mph will also continue, particularly for California, Nevada, and southern Idaho, as well as through the Cascade gaps. Mostly wet monsoon shower and thunderstorm activity will likely continue to be prevalent over Arizona into the southern Great Basin, very similar to Saturday. Not as much shower and thunderstorm activity is expected east of the divide as compared to previous days and the Pacific Northwest is likely to be dry. Temperatures over the Gulf Coast will rise to near 100°F and continued breezy northerly flow will keep very dry conditions in place with RH as low as 20-25%. Portions of Texas and Oklahoma will also heat up and RH will fall to as low as 15-20% with breezy southerly flow of 15-25 mph.
