Grapefruit Complex (6 fires), Upper Yukon Zone, BLM. CIMT (AK Team 3). Started on DNR land 30 miles northeast of Fairbanks, AK. Timber and hardwood litter. Moderate fire behavior with creeping, single tree torching and smoldering. Numerous structures threatened. Evacuations, area and trail closures in effect. Precipitation occurred over the fire area yesterday.

Riley, Tanana Zone, BLM. CIMT (AK Team 2). Started on NPS land nine miles southeast of Healy, AK. Timber and hardwood litter. Active fire behavior with isolated torching, running and creeping. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Deception Pup, Upper Yukon Zone, BLM. Started on DNR land three miles northwest of Central, AK. Timber. Minimal fire behavior. Structures threatened.

* **Montana Creek**, Mat-Su Area, Alaska DOF. Fifteen miles south of Talkeetna, AK. Timber. Moderate fire behavior with creeping and smoldering.

McDonald, Military Zone, BLM. Started on DOD land 9 miles southwest of Salcha, AK. Timber, hardwood litter and short grass. Moderate fire behavior with backing and creeping. Structures threatened. Last narrative report unless significant activity occurs.

Deep, Tanana Zone, BLM. Started on DNR land eight miles southwest of Lake Minchumina, AK. Timber. Active fire behavior. Residences threatened. Last narrative unless significant activity occurs.

Predictive Services Discussion:

Alaska is forecast to see a somewhat cooler air mass move in from the northwest. This will keep a chance of showers through the day. The lowest minimum relative humidity is forecast to be around 30% in the eastern interior. For California and the desert southwest, the minimum relative humidity will fall into the single digits, up to around 20% with high temperatures forecast to range from 105 for the Central Valley of California, to 120 in the desert southwest. The Sacramento Valley is also forecast to see breezy conditions out of the north northwest, with gusts of around 30 miles per hour. The Great Basin, and interior Washington and Oregon, are forecast to see highs in the 80s to low 90s, with relative humidity between 10% and 20%. In the Four Corners area, monsoons will be lower coverage as they begin to wind down this week. This will allow for a warming trend to begin. The High Plains in Colorado and Texas are also forecast to continue with highs in the lower 90s for southern Colorado, to around 105 for Oklahoma and a large portion of Texas. The Texas and Oklahoma Panhandles are forecast to have sustained southwesterly wind around 15 miles per hour, with gusts around 30 miles per hour in Oklahoma.
