Smokehouse Creek, Texas A&M Forest Service. CIMT (SA Team 2). CIMT is also managing the Windy Deuce and Grape Vine Creek fires. Started on private land one mile north of Stinnett, TX. Grass and brush. Active fire behavior with wind-driven runs and backing. Energy infrastructure threatened.

Windy Deuce, Texas A&M Forest Service. Started on private land six miles east of Masterson, TX. Grass and brush. Active fire behavior with running. Numerous residences and energy infrastructure threatened.

Grape Vine Creek, Texas A&M Forest Service. Started on private land nine miles southwest of Lefors, TX. Active fire behavior with running.

Catesby, Oklahoma DOF. Four miles south of Catesby, OK. Grass and timber. Active fire behavior with single tree torching and short-range spotting.

Slapout, Oklahoma DOF. Six miles west of Laverne, OK. Grass and brush. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

Magenta, Texas A&M Forest Service. Started on private land seven miles south of Channing, TX. Grass and brush. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

Robert Walker Rd, Alabama Forestry Commission. Four miles northwest of Citronelle, AL. Brush. Minimal fire behavior.

Wasington, Alabama Forestry Commission. Four miles southeast of Leroy, AL. Brush. Minimal fire behavior.

Predictive Services Discussion:

Breezy and dry westerly winds creating elevated fire weather conditions are likely across the Trans Pecos and Big Bend today, but winds overall will be lighter with much cooler temperatures across the central and southern Plains. A strong cold front will move from the Mississippi Valley today to the East Coast by Wednesday bring widespread rain to the eastern US, heaviest across the Lower Mississippi Valley, Southeast, Mid-Atlantic, and the Northeast. A storm will move through the West through midweek bringing light to moderate precipitation, with snow levels 2,000 to 4,000 feet across the northern half of the West, and 5,000 to 7,000 feet from California to the southern Rockies. As this storm moves onto the Plains, breezy and dry southwesterly winds will return to portions of the central and southern High Plains Wednesday into Thursday. However, more moisture will be drawn northward with widespread precipitation for the eastern Plains to the Appalachians, with light precipitation for the High Plains late Thursday into Friday behind the cold front. Breezy trade winds will continue across Hawai'i with widespread showers through midweek, especially for the windward sides, and potential flooding on the Big Island. Near to below normal temperatures will continue over Interior Alaska, while periods of light precipitation continue across western and southern Alaska.
