NIMO Team 1 has been mobilized to assist Disaster Recovery Staff with organizing a safe, efficient and orderly transition from response to recovery in all hurricane impacted areas across the Southern Region.

Hurricane Helene Support – NC, North Carolina Forest Service. CIMT (NC State). Primary mission is to coordinate emergency road clearing efforts, perform damage assessments and deliver commodities throughout western North Carolina.

* **Bean Fork Road**, Kentucky DOF. Started on private land 8 miles west of Jackson, KY. Hardwood litter and light slash. Moderate fire behavior with backing and creeping. Residences threatened. Precipitation occurred over the fire area yesterday.

* **Poplar Creek**, Virginia DOF. Three miles northwest of Grundy, VA. Timber. Moderate fire behavior. Structures threatened.

* **Gabriel Branch**, Kentucky DOF. Started on private land 2 miles east of Kimper, KY. Hardwood litter. Moderate fire behavior with flanking and backing.

Forked Mouth 9, Kentucky DOF. Started on private land 5 miles west of Hazard, KY. Hardwood litter and grass. Minimal fire behavior with backing and creeping. Structures threatened. Precipitation occurred over the fire area yesterday.

Hudson, Texas A&M Forest Service. Started on private land 5 miles east of Bastrop, TX. Timber, brush and grass. Minimal fire behavior with smoldering. Residences threatened.

Rush, Wichita Mountains National Wildlife Refuge, FWS. Fifteen miles northwest of Lawton, OK. Timber, grass and brush. Minimal fire behavior. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

* **Schoolhouse**, Virginia, DOF. Nine miles southeast of Clintwood, VA. Timber. Minimal fire behavior.

Predictive Services Discussion:

Strong northeasterly Santa Ana winds will continue in southern California, with gusts to 60 mph continuing this morning before gradually weakening with gusts of 30-40 mph overnight. Relative humidity will remain as low as 5% during the day, with poor overnight recovery tonight. Farther north, lighter easterly winds of 10 mph are expected in central and northern California with continued low afternoon relative humidity. A winter storm will continue over New Mexico and Colorado, with snow above 4,000 to 5,000 feet and amounts of up to 2 feet in the Sangre de Cristo Mountains. Widespread showers are expected across the central and southern Plains, with scattered thunderstorms, some severe, across much of Texas. Scattered showers and isolated thunderstorms are expected across the Southeast and Lower Mississippi Valley with generally light amounts. Mild and dry conditions are forecast from the Northwest into the northern Plains and Great Lakes.
