Rail Ridge, Prineville, District, BLM. CIMT (CA Team 10). Fifty-one miles northwest of Burns, OR. Grass, brush and timber. Active fire behavior with wind-driven runs, torching and short-range spotting. Numerous structures, communication infrastructure and sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

Devils Knob, Umpqua NF, USFS. CIMT (NW Team 13). IMT is also managing the Milepost 98 fire. Five miles southeast of Tiller, OR. Timber. Active fire behavior with spotting, running and backing. Structures threatened. Evacuations in effect.

Milepost 98, Pendleton Unit, ODF. One mile south of Canyonville, OR. Light slash and timber. Active fire behavior with uphill runs, flanking and backing. Structures threatened. Road closures in effect.

Willamette Complex (4 fires), Willamette NF, USFS. CIMT (CA Team 13) and CIMT (NW Team 2). IMTs are also managing the Ore fire. Eight miles southeast of Oakridge, OR. Timber, brush and grass. Moderate fire behavior with backing, group torching and spotting. Communication and transportation infrastructure threatened. Area, road and trail closures in effect.

Ore, Willamette NF, USFS. Seven miles northeast of Blue River, OR. Closed timber litter and timber. Moderate fire behavior with isolated torching, flanking and backing. Structures threatened. Area, road and trail closures in effect.

Wiley Flat, Ochoco NF, USFS. CIMT (CA Team 1). Thirty-one miles southeast of Prineville, OR. Timber, brush and grass. Active fire behavior with group torching, flanking and backing. Structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Fossil Complex (3 fires), Fossil Unit, ODF. IMT 1 (ODF Team 2). Two miles northwest of Spray, OR. Grass and timber. Active fire behavior with spotting, wind-driven runs and torching. Structures threatened. Evacuations and road closures in effect.

Shoe Fly, Prineville Unit, ODF. IMT 1 (ODF Team 1). Forty-five miles northeast of Prineville, OR. Brush, grass and timber. Active fire behavior with flanking, backing and creeping. Numerous structures and communication infrastructure threatened. Evacuations and road closures in effect.

Diamond Complex (2 fires), Umpqua NF, USFS. CIMT (SA Team 3). IMT is also managing the Middle Fork fire. Eighteen miles southwest of Chemult, OR. Timber. Minimal fire behavior with creeping and smoldering. Communication and energy infrastructure threatened. Area, road and trail closures in effect.

Middle Fork, Crater Lake NP, NPS. Fourteen miles northeast of Union Creek, OR. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Homestead Complex (4 fires), Umpqua NF, USFS. CIMT (NW Team 8). Thirty miles northeast of Glide, OR. Timber, closed timber litter and brush. Moderate fire behavior with flanking, creeping and single tree torching. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Copperfield, Klamath Unit, ODF. IMT 1 (ODF Team 3). Five miles southeast of Chiloquin, OR. Timber, brush and grass. Minimal fire behavior with smoldering. Numerous structures and energy infrastructure threatened. Evacuations and road closures in effect.

Whisky Creek, Mt. Hood NF, USFS. CIMT (NW Team 12). IMT is also managing the Sandstone fire. Six miles southeast of Cascade Locks, OR. Timber, brush and closed timber litter. Moderate fire behavior with backing, flanking and creeping. Structures, energy and transportation infrastructure threatened. Area, road and trail closures in effect.

Sandstone, Mt. Hood NF, USFS. Nine miles southwest of Ripplebrook, OR. Brush, closed timber litter and timber. Minimal fire behavior with smoldering and creeping. Area, road and trail closures in effect.

Buck Creek, Fremont-Winema NF, USFS. CIMT (NW Team 10) mobilizing. Thirty miles southwest of Silver Lake, OR. Timber and medium slash. Extreme fire behavior with running, torching and crowning.

Bowman Well, Lakeview District. BLM. Twenty miles northeast of Silver Lake, OR. Brush and grass. Moderate fire behavior with single tree torching, creeping and smoldering. Numerous structures threatened. Evacuations and area closures in effect. Reduction in acreage due to more accurate mapping.

Lane 1, East Lane Unit, ODF. CIMT (AK Team 1) Fifteen miles southeast of Springfield, OR. Timber, closed timber litter and light slash. Moderate fire behavior with backing and creeping. Structures threatened. Area, road and trail closures in effect.

Huckleberry Ridge, Pacific Cascade Region, DNR. Twenty miles south of Pe Ell, WA. Heavy slash and timber. Moderate fire behavior with backing, spotting and torching. Area and road closures in effect.

Pioneer, Southeast Region, Washington DNR. Started on private land 10 miles southeast of Stehekin, WA. Timber and grass. Minimal fire behavior. Numerous structures threatened. Area, road and trail closures in effect.

Battle Mountain Complex (2 fires), Pendleton Unit, ODF. Eight miles north of Ukiah, OR. Grass, hardwood litter and timber. Minimal fire behavior with smoldering. Numerous structures threatened.

Ruby, North Cascades NP, NPS. Thirty-two miles northwest of Stehekin, WA. Timber and brush. Moderate fire behavior with single tree torching, creeping and backing. Area and trail closures in effect.

Williams Mine, Gifford Pinchot NF, USFS. Four miles northwest of Trout Lake, WA. Brush, timber and light slash. Minimal fire behavior with creeping and smoldering. Energy infrastructure threatened. Area, road and trail closures in effect.

Easy, Okanogan-Wenatchee NF, USFS. Seventeen miles west of Mazama, WA. Timber, closed timber litter and brush. Moderate fire behavior with creeping. Structures threatened. Area, road and trail closures in effect.

Firestone, Deschutes NF, USFS. Twenty-one miles north of Fort Rock, OR. Grass, brush and timber. Extreme fire behavior with torching, short crown runs and short-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Flat Top, Deschutes NF, USFS. Ten miles north of Fort Rock, OR. Grass, brush and timber. Extreme fire behavior with torching, short crown runs and short-range spotting. Structures threatened. Area, road and trail closures in effect.

* **Backside**, Deschutes, NF, USFS. CIMT (NW Team 3) is mobilizing Ten miles west of Bend, OR. Timber and slash. Moderate fire behavior with creeping, smoldering and single tree torching. Structures threatened. Area, road and trail closures in effect.

Sage Hen, Burns District, BLM. Ten miles west of Burns, OR. Grass, brush and timber. No new information.

Crazy Creek, Ochoco NF, USFS. Sixteen miles northeast of Paulina, OR. Grass, brush and timber. No new information.

Red, Deschutes NF, USFS. Eighteen miles west of Crescent, OR. Timber and closed timber litter. No new information.

Davis, Truckee Meadows Fire Protection District. CIMT (SW Team 1). Fifteen miles south of Reno, NV. Grass, brush and timber understory. Active fire behavior with wind-driven runs, group torching and spotting. Numerous structures, transportation and energy infrastructure threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Lava, Boise NF, USFS. Transfer of command will occur CIMT (SA Team 1) tomorrow. Twelve miles southwest of Cascade, ID. Timber and brush. Extreme fire behavior with crowning, long-range spotting and wind-driven runs. Structures threatened. Area, road and trail closures in effect.

Wapiti, Boise NF, USFS. CIMT (GB Team 7). Fourteen miles west of Stanley, ID. Grass, brush and timber. Active fire behavior with wind-driven runs, group torching and long-range spotting. Numerous structures and several communities threatened. Area, road and trail closures in effect.

Boulder, Boise NF, USFS. CIMT (RM Team 3). IMT is also managing the Snag, Goat and Dollar fires. Nine miles southwest of Cascade, ID. Timber and brush. Active fire behavior with short crown runs, group torching and spotting. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Snag, Boise NF, USFS. Ten miles east of Cascade, ID. Timber and brush. Moderate fire behavior with backing, group torching and spotting. Residences and energy infrastructure threatened. Area, road and trail closures in effect.

Goat, Boise NF, USFS. Eleven miles southeast of Cascade, ID. Timber and brush. Active fire behavior with uphill runs, group torching and spotting. Communication and energy infrastructure threatened. Area, road and trail closures in effect.

Dollar, Boise NF, USFS. Eighteen miles northeast of Cascade, ID. Timber and brush. Minimal fire behavior with backing, isolated torching and smoldering. Area, road and trail closures in effect.

Red Rock, Salmon-Challis NF, USFS. CIMT (CA Team 4) is mobilizing. Fifteen miles west of Salmon, ID. Timber and light slash. Active fire behavior with group torching, running and long-range spotting. Structures threatened. Area closures in effect.

Middle Fork Complex (2 fires), Boise NF, USFS. CIMT (GB Team 5). Nine miles east of Garden Valley, ID. Timber and brush. Moderate fire behavior with backing, flanking and group torching. Communication infrastructure threatened. Area, road and trail closures in effect.

Fish Creek, Bridger-Teton NF, USFS. CIMT (NR Team 2). Twenty-two miles southeast of Moran, WY. Timber and brush. Active fire behavior with short crown runs, group torching and long-range spotting. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Predictive Services Discussion:

A deep upper-level trough over the Pacific Ocean will start to near the Pacific Coast. This will start a pattern change that will continue through the end of the week. Ahead of this system, winds across the Intermountain West will continue to gust 20 to 30 mph through the afternoon. Latest model runs show Cascade Gap winds increasing ahead of the trough. RH across much of the West will remain low at 5 to 20%, though west of the Cascades humidity will start to increase substantially only dropping to 30 to 40%. The heat wave will continue through the Central Valley and into Arizona with highs remaining 100 to 110 degrees. The High Plains will continue to see above normal temperatures, with highs on the Northern Plains up into the mid to upper 90s. Some lingering monsoonal moisture caught under the ridge will keep some isolated to scattered mixed wet/dry showers and thunderstorm going around the Four Corners region. The cold front associated with the incoming trough will be moving through the Northwest overnight.

In the east with the low moving out of eastern Canada and the flat ridge in the west spreading farther east, expect the heat to spread across the Midwest and as far east as the Appalachians. RH will continue to be lower across the Southern Plains into the Ohio and Tennessee valleys from 20 to 30%. Winds in the High Plains to the Western Great Lakes will gust 20 to 30 mph, otherwise winds will generally remain light. Tropical Storm Francine in the western Gulf will remain over the Gulf, but stronger winds and increased rain will continue to impact the South Texas Coast.
