* **Two Barrel**, National Forests in Florida, USFS. Twelve miles northeast of Wewahitchk, FL. Southern rough, timber and grass. Moderate fire behavior with creeping, running and flanking.

* **Chestnut Mtn**, Chattahoochee-Oconee NF, USFS. Six miles northwest of Resaca, GA. Timber. Moderate fire behavior with flanking. Structures threatened. Road closures in effect.

* **KC 450**, Texas A&M Forest Service. Started on private land nine miles southeast of Junction, TX. Brush. Minimal fire behavior with smoldering and creeping.

* **Rough Horn Rd**, North Carolina Forest Service. Nine miles northwest of Chadbourn, NC. Timber. Active fire behavior with flanking. Residences threatened.

* **Cedar Knob**, Oklahoma DOF. Four miles east of Talihina, OK. Timber and brush. Active fire behavior with running and flanking.

* **Polk Treat Mountain**, Georgia Forestry Commission. Nine miles southwest of Cedartown, GA. Timber. Active fire behavior with short crown runs, uphill runs and isolated torching.

* **McBean Club**, Georgia Forestry Commission. Seven miles southwest of Jackson, GA. Timber. Moderate fire behavior with smoldering and creeping.

* **TH Buster Rogers**, Georgia Forestry Commission. Eight miles northeast of Glennville, GA. Timber. Active fire behavior with isolated torching, wind-driven runs and short-range spotting. Structures threatened.

* **Colbin Gap**, Alabama Forestry Commission. Started on private land three miles east of Glencoe, AL. Brush. Active fire behavior.

* **Calhoun Co**, Alabama Forestry Commission. Five miles north of Jacksonville, AL. Brush. Active fire behavior.

Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Very dry conditions will continue in the Southeast, with relative humidity as low as 15% and areas of poor overnight recovery in the Appalachians. Breezy westerly winds will also develop on Saturday creating elevated to locally critical conditions. Breezy westerly winds will develop with an upper level low in the Southwest and southern High Plains this weekend creating elevated conditions. Areas of light rain are also possible on Sunday in the Texas and Oklahoma panhandles towards the Red River. Winds will increase again in the Southwest Monday but with areas of precipitation, mainly west of the Divide. Strong low pressure will develop in the central Plains Tuesday with widespread critical to extremely critical conditions across the southern Plains, which will be partially mitigated in areas that receive rain Sunday. Another wind event is possible on the southern Plains late next week.

Elsewhere across the US, warm temperatures are expected across the West through tomorrow before cooler temperatures and periods of light to moderate precipitation occur next week. Relatively dry conditions are expected into early next week. Widespread rain is expected mid-next week from the Mississippi Valley to the East Coast as the storm on the Plains moves east, but much of Florida will remain dry for the next week. In Alaska, above normal temperatures are likely across much of the state, with any precipitation likely confined to the southern and western coasts.
