* **840 Road**, Oklahoma DOF. Five miles southeast of Angora, OK. Timber and grass. Extreme fire behavior with wind-driven runs, group torching and long-range spotting. Numerous structures threatened. Evacuations in effect.

* **Windmill**, Texas A&M Forest Service. Started on private land 22 miles south of Perryton, TX. Grass and brush. Extreme fire behavior with wind-driven runs and long-range spotting. Structures threatened. Road closures in effect.

* **Rest Area**, Texas A&M Forest Service. Started on private land five miles west of Alanreed, TX. Grass. Extreme fire behavior with wind-driven runs and spotting.

* **Hickory Hill Road**, Oklahoma DOF. Three miles northeast of Arcadia, OK. Grass and timber. Extreme fire behavior with wind-driven runs, long-range spotting and torching. Numerous structures threatened. Evacuations in effect.

* **Euchee Valley**, Oklahoma DOF. Four miles southwest of Cushing, OK. Grass and timber. Extreme fire behavior with wind-driven runs, long-range spotting and torching. Structures threatened.

* **1980 Road**, Oklahoma DOF. Three miles northeast of Elk City, OK. Timber and grass. Extreme fire behavior with wind-driven runs, running and long-range spotting. Structures threatened.

* **Post Oak**, Oklahoma DOF. Three miles northeast of Maguire, OK. Timber and grass. Extreme fire behavior with wind-driven runs and torching.

* **Onyx**, Oklahoma DOF. Three miles northeast of Maguire, OK. Grass and timber. Extreme fire behavior with running and torching.

* **Davis**, Oklahoma DOF. Three miles southeast of Stigler, OK. Timber and grass. Active fire behavior with wind-driven runs and flanking.

* **Big Draw**, Oklahoma DOF. Four miles southwest of Battiest, OK. Timber. Moderate fire behavior with wind-driven runs and torching.

* **Mullins Cove Road**, Tennessee DOF. Six miles northwest of Hill City, TN. Hardwood litter. Active fire behavior with flanking and uphill runs.

Curry Branch, Kentucky DOF. Started on Forest Service land nineteen miles northeast of Corbin, KY. Hardwood litter, light slash and brush. Minimal fire behavior with smoldering.

Bailey Drive, North Carolina Forest Service. Two miles west of Bakersville, NC. Medium slash. Minimal fire behavior with smoldering. Structures threatened.

Millis Savannah, National Forests in North Carolina, USFS. Six miles southwest of Newport, NC. Southern rough and timber. Minimal fire behavior with smoldering and creeping.

Covington Drive, South Carolina Forestry Commission. CIMT (FL State Team 1). Two miles west of Myrtle Beach, SC. Southern rough and timber. Minimal fire behavior with smoldering and creeping. Numerous residences threatened.

Cottonwood Creek, Texas A&M Forest Service. Started on private land 30 miles south of Brownwood, TX. Grass and brush. Minimal fire behavior.

Dade Long Branch, Georgia Forestry Commission. Started on private land seven miles south of Rising Fawn, GA. Hardwood litter and timber. Minimal fire behavior with smoldering.

Walker Mission Ridge Drive, Georgia Forestry Commission. Started on private land one mile west of White Oak, GA. Hardwood litter and timber. Minimal fire behavior with smoldering. Structures threatened.

Stripes, Oklahoma DOF. Three miles east of Slick, OK. Hardwood litter, grass and timber. No new information.

Hamby Ridge, Oklahoma DOF. Four miles southeast of Colcord, OK. Timber. No new information.

Predictive Services Discussion:

Strong westerly sustained winds 20-30 mph with gusts to 50 mph amid minimum relative humidity of 10-20% will develop across much of central and South Texas creating critical fire weather conditions. Breezy north winds of 15-25 mph with gusts to 35 mph amid similar relative humidity will create elevated to critical conditions from central Nebraska south to the Texas Panhandle and western Oklahoma. Breezy downslope southerly winds amid low relative humidity will also occur on the west slopes of the Appalachians into the afternoon before a strong cold front brings rain to the area. This cold front will move through the Great Lakes, Ohio/Tennessee Valleys, Deep South, and Appalachians with severe thunderstorms, and several strong tornadoes are likely in the Deep South. On the northwest side of the storm, blizzard conditions in much of central and western Minnesota this morning will diminish during the day as snow ends and winds gradually decrease. A Pacific storm will bring low elevation rain and heavy mountain snow to the northern half of the West, while drier conditions are expected in southern California to the Southwest. New normal temperatures are expected in Alaska today with snow showers for portions of south-central Alaska. Trade winds will become lighter today and more out of the southeast along with an increase in moisture and showers across the state.
